Minutes of 13th Empanelment and Disciplinary committee Meeting of Suvarna

Dr. Sudarshan .H, Chairman Empanelment and Disciplinary Committee, SAST, Bangalore welcomed all the members present for the meeting.

Thereafter, subjects as per the agenda were taken up for discussion.

1. Confirmation of the minutes of the 12th EDC meeting held on 18.01.2011:

The Proceedings of the EDC Meeting held on 18.01.2011 were confirmed.

Regarding Empanelment of Shri Basavalingappa Nisty Hospital, Gulbarga it was decided to go ahead with the decision already taken in the EDC meeting held on 25.11.2010 subject to the condition, that the hospital fulfills the criteria fixed for minimum number of beds prescribed by the Trust.

2. Review of the action taken on the proceedings of the last meeting held on 18.01.2011

Action taken on the proceedings of the last meeting held on 18.01.2011 was reviewed.

The detail file wise report prepared in respect of sixty network hospitals by the ISA was reviewed. It was decided not to give room_for such omissions and commissions in future. It was also decided to keep the observations made by the ISA at the time of renewal of the network hospitals for next year.

The Chairman also stated that intimation should be sent to all the network hospitals who have completed one year to send application for renewal along with information regarding specialists services available and progress achieved under each speciality for which the hospital is empanelled along with DD for Rs.5000/- towards renewal fees in the name of the Trust.

In so far as inactive Network hospitals in Gulbarga and Belgaum division, are concerned it was decided to request them to take part in the implementation of the scheme. If not, to delete them from the list of Network hospitals.

3. Empanelment of Hospitals:

After detailed discussions, it was decided to accord approval for empanelment of the following hospitals under VAS Scheme for the specialities mentioned below.

5. To consider the report received from Dr. Devadasan regarding Indus Westside Hospital Bangalore for inclusion of additional speciality.

The report of Dr. Devadasan was gone through. It was decided to empanel Indus West Side Hospital, Bangalore for Cardiology and Cardiothoracic surgery.

6. Consideration of report received from Joint Director SAST regarding complaint received from Sri. Manjunath of Hospet.

The report received from the Joint Director, SAST was gone through. According to it the hospital top management has agreed to refund the amount of Rs. 44,645/- to the Complainant within a week. The Chairman expressed that, he is happy to note that the problem is settled.

7. Consideration of application received from Ravi Kirloskar Memorial Hospital for sanction of Additional Specialities.

It was decided to re-inspect the hospital and obtain report regarding number of surgeries done under each speciality for which the hospital has applied for empanelment.

8. Consideration of report received from ISA regarding complaints against.

1. Patil Nursing Home, Gulbarga.

The detail report provided by team of ISA (FHPL) officers was discussed at length. Dr. Ravindra Patil is not strictly qualified Urologist. However, he has provided service to large number of patients in the area. Gulbarga is backward area. Apart from the above the report given by ISA team about random checking of patients treated by Dr. Ravindra Patil do not show any fraud. In view of the above, it was decided to release the claims of the hospital (which were withheld) as a special case. This should not be precedence for any other institution or person.

Henceforth, Dr. Ravindra Patil is not entitled to perform Urology cases under VAS scheme. He shall also not perform Urology surgeries in other empanelled hospitals under VAS scheme as visiting surgeon.

Dr. Vittal Krishna who is an empanelled doctor of the hospital can perform Urology cases under VAS scheme.

2. Shree Hospital, Bidar.

The report received from ISA team and the documents enclosed to the report were examined and detail discussion was held. From the report and the documents enclosed to the report it is clear that there is primafacie fraud.

In view of the above, the following decisions were taken.

- 1. To blacklist the hospital permanently.
- 2. To intimate the above decision to Yeshasvini Trust also.
- 3. Not to make further payment to the hospital.
- 4. To examine the possibility of recovering the bills of the hospital already settled.
- 5. To request the Executive Director to take Criminal Action against the persons involved in the fraud.

The good work done by the team of FHPL in detection of fraud and collection of relevant important documents to prove the irregularities in the hospital were appreciated.

As there were no subjects for discussion, the meeting was concluded with thanks by the chair.
