Action taken on the proceedings of the last meeting held on 18.07.2011 was reviewed.

Representatives of FHPL briefed the Committee about the efforts made regarding the establishment of KIOSK by the NWHs. However, there is poor response from hospital side. The Chairman stated that, all the NWHs should establish KIOSK without any delay. Hence, it was decided to take measures such as, withholding of payment to the active NWHs giving one month time to make arrangement for establishment of KIOSK. The FHPL was requested to take follow up measures in this regard. It was also decided that, the action taken should be brought to the notice of the Chairman EDC.
